The SELECT BOARD, as Local Licensing Authority, will conduct a hybrid public hearing on **Tuesday, April 14, 2026**, at 6:00 PM. The **in-person** portion of the meeting will be held in the **Conference Meeting Room** at the **Westwood Public Library** located at **660 High Street, Westwood MA**. **Should the in-person meeting room location need to be changed, the Town website will be updated to notify those wishing to attend.**

The remote meeting option will be provided via Zoom pursuant to Governor Maura Healey signing into law, an Act Extending pandemic related authorizations related to public meetings, allowing remote meeting options for public bodies through June 30, 2027.
